Application Instructions

A cloth is soaked with CLEANCHOICE SPORT B MINERAL SPIRITS and the floor to be cleaned is scrubbed by machine or manually in sections. After a short waiting period, the dissolved wax film is wiped up with a dry cloth. Always use a fresh cloth so that the wax film is not spread but absorbed by the cloth. Depending on the extent of the soilings and the thickness of the film to be removed the cleaning procedure is repeated. Please see to it that no puddles of CLEANCHOICE SPORT B MINERAL SPIRITS remain on the finished floor. Soilings such as rubber marks, grease and colour stains are removed by rubbing with a soft cloth soaked with CLEANCHOICE SPORT B MINERAL SPIRITS.

CLEANCHOICE SPORT B MINERAL SPIRITS is a basic cleaner suitable for floors treated with wax-containing care products

(BRILLIANCE AQUASATINPOLISH and floors treated with CLASSIC BASEOIL, CLASSIC BASEOIL COLOR and CLASSIC 100 PROOIL). After careful cleaning with CLEANCHOICE SPORT B MINERAL SPIRITS one of our compatible maintenance or CLASSIC OIL products is applied immediately.

Regular Cleaning:

For daily or regular floor care to remove surface dirt, floor should be wiped with a damp cloth with CLEANCHOICE SPORT B DAILY CLEAN.

Maintenance and Care

Regular cleaning and care with compatible care products is essential for extended floor life and beauty. If a floor is damaged and/or the finish coat is worn through to the wood, cleaning water may penetrate and have a greying effect on the wood. In this case, the floor should be sanded and refinished as soon as possible. Use CLEANCHOICE SPORT B MINERAL SPIRITS for basic cleaning and tough stain removal. Before allowing traffic, use BRILLIANCE AQUASATINPOLISH for regular maintenance.

System Recommendations

With tough dirt, stains and film build-up, use CLEANCHOICE SPORT B MINERAL SPIRITS full strength or diluted.
