CLEANCHOICE SPORT B POWER CLEAN is a waterborne floor cleaner developed for the removal of tough dirt, stains, self-shining films and some wax coats on finished hardwood and other type floors.

Application Instructions

1. Basic Cleaning for sealed surfaces:

First, the floor is moistened with water. CLEANCHOICE SPORT B POWER CLEAN is spread uniformly over the floor and allowed to sit for about 5 minutes diluted at a ratio of approximately 2:1 water to CLEANCHOICE SPORT B POWER CLEAN. Depending on the amount of dirt or the thickness of film to be removed, the floor may require scrubbing either manually or mechanically. If necessary, the procedure can be repeated. As dirt, stains and care films are dissolved, the floor should be wiped with a damp cloth. For extremely difficult dirt and stain removal, use full strength. For unknown substrates pretest at not direct visible spot.

Caution: Floor should not be soaked with water, which could result in swelling of wood.

2. Intermediate Cleaning for sealed and oiled surfaces:

For daily or regular floor care to remove surface dirt, floor should be wiped with a damp cloth with a 5% (½ cup) solution of cleaner to 1 gallon of water.

Intensive cleaning for oiled surfaces

The floor is moistened. CLEANCHOICE SPORT B POWER CLEAN is spread out and scrubbed manually or mechanically after a short exposure. Depending on the degree of soiling and the thickness of the care film, apply pure or 1: 1 diluted with water and repeat the cleaning process if necessary.

The loosened dirt film must be taken up immediately. Afterwards, always wipe with clear water. After this intensive cleaning, further treatment with CLASSIC BASEOIL, BRILLIANCE FITPOLISH, BRILLIANCE OILCARE, CLASSIC 100PROOIL or BRILLIANCE SUPERWAX may be necessary. For deep cleaning with oil removal, we recommend BRILLIANCE BIOSOAP or CLEANCHOICE SPORT B MINERAL SPIRITS.

Maintenance and Care

Regular cleaning and care with compatible care products is essential for extended floor life and beauty. If a floor is damaged and/or the finish coat is worn through to the wood, cleaning water may penetrate and have a greying effect on the wood. In this case, the floor should be sanded and refinished as soon as possible. Use CLEANCHOICE SPORT B POWER CLEAN for basic cleaning and tough stain removal. Before allowing traffic, use BRILLIANCE EVERCLEAR for regular maintenance and a self-shining, non-slip floor.

System Recommendations

With tough dirt, stains and film build-up, use CLEANCHOICE SPORT B POWER CLEAN full strength or diluted. BRILLIANCE EVERCLEAR should be used as a floor care system on all Berger-Seidle System finishes after they have been fully cured and before traffic is allowed on the floor.
